Motion to approve removing the grate installed in the culvert this winter was made by Jessica Underwood and seconded by John Rosene. 5 ayes 0 nays 0 absent

## **Commissioners' Discussion:**

The January 2018 Treasurer's Report will be completed later in February and distributed to the Board for approval at the March meeting.

Dennis Kelly gave the Board an overview of the proposed Algonquin Road expansion project.

Dennis Kelly will meet with the Park District Administrators to clarify changes and updates needed in the rental application forms and manual and the changes will be presented at the March board meeting.

The Board reviewed several rental applications from the Riding Club of Barrington Hills and the Fox River Valley Pony Club.

Jessica Underwood reported on the Advisory Committee Meeting:

- The jump stall has been locked on several occasions when it should have been open. The substitute groundskeeper is now aware of the locking procedures.
- A request for jumps to be stored along the indoor arena aisle was

denied as this would violate fire codes.

- Sand bags for the outdoor jumps need to be located or new ones purchased.
- The AC inquired when the ditch in the stadium field will be installed. The construction will be scheduled when the ground thaws in the Spring.
- Used jumps from Showplace Productions (a total of 10 jumps) are available if the District would like to purchase them.
- The Pony Club said they will leave 8-10 jumps in the stadium field but are unsure of what types of jumps they will be and their quality.
- A clarification in the Pony Club Agreement with the Park District is needed to clarify the Pony Club's responsibility in providing jumps in the Stadium Field, with specific details of the exact type, quality and number of jumps.
- If the Park District purchases new jumps for the Stadium Field the jumps will need to be clearly marked (stenciled) to differentiate them from FRVPC jumps. Also, the jumps will have to be removed before any Pony Club Shows.
- The parking lot lights in the front parking lot are not working properly and an electrician should be called.
- The new Advisory Committee members names and emails should be posted to the District's website.
- AC questioned if box fans used during horse shows are covered under the Park District's insurance policy.
- The AC recommends removing the grates installed in the culvert instead of building a fence around the culvert. Scott Sinnett, from Sinnett Excavating, recommends taking the grates out in the winter when the ground is still frozen and that taking out the grates will not present any issues with the swale. Gigi Iacovelli will contact Sinnett to have the grates removed.

Keys to the Riding Center Facility were given to the new Commissioners, Gigi Iacovelli and Jessica Underwood.
